## THE ISSUE

Britain is one of South Africa's major trading partners and the largest single foreign investor in apartheid, with in excess of £5,000 millions worth of British-owned investment in South Africa. Many British companies make huge profits in South Africa from the exploitation of black workers.

It is now 20 years since the first appeal was made by black South Africans for the boycott of South Africa. Yet the British Government's policy continues to be one of promoting trade with apartheid and at the United Nations Britain has consistently vetoed proposals for mandatory action to end economic collaboration with South Africa.

Now, the liberation struggle in Southern Africa is intensifying. British trade unionists can contribute to that struggle by denying the racist regime the economic support it requires — and unless we are able to break these links Britain will be drawn more and more into defending the status quo — apartheid.

## THE CONFERENCE

The AAM is organising the conference as part of a major campaign in the trade union movement to stimulate activity by trade unionists and to mobilise the labour movement in support of a new Government policy of confrontation with apartheid.

## THE PROGRAMME

The conference will feature a programme of speakers, documents and discussion following three themes:

- Britain's stake in apartheid
- The case for economic sanctions
- The need for action

The agenda has been structured to promote the maximum discussion.

## SPONSORS
