Resistance and repression The Trade Union Movement in South Africa

"Since I participated in a delegation to South Africa in 1986, the trade union movement has blossomed into one of the leading forces for democratic change in that country.

The Congress of South African Trade Unions (COSATU) has more than doubled in size since its founding congress in 1985. With the United Democratic Front, it is a central organiser of the mass defiance campaign, which has shaken the apartheid regime to its very foundations. There is also growing co-operation between COSATU, the National Council of Trade Unions (NACTU) and other trade union organisations to oppose the apartheid system.

Since the imposition of the State of Emergency in 1986 the democratic trade union movement has shouldered the brunt of the attacks by the apartheid regime against the Mass Democratic Movement.

These attacks have taken various forms. Direct attacks on union leaders and activists by security forces. Detention and imprisonment. The ransacking and destruction of union buildings. The use of vigilantes to murder union activists. The use of racist courts.

The trade union movement in South Africa needs our solidarity now in the face of these attacks. International action *does work*. Under auspices of the Anti-Apartheid Movement's *Joint Campaign* and in cooperation with the TUC, British trade unions have successfully campaigned for the release of *Moses Mayekiso*, *General Secretary of the National Union of Metalworkers of South Africa*, trade union stalwarts Oscar Mpetha and Harry Gwala, and SWAPO Secretary of Labour Jason Angula and helped to stop the execution of eight trade unionists.

But much more needs to be done. Trade unionists remain under the threat of repression as long as the apartheid system exists. That is why this conference has been convened – to strengthen our campaigning. Please make every effort to ensure that your branch is represented at this very important conference.

The 'Resistance and Repression' Conference has been convened to –


- publicise the role of the non-racial trade union movement in resisting apartheid;
- expose and highlight the attacks on the trade union movement in South Africa;
- intensify the campaign against the repression of trade unionists in South Africa;
- mobilise solidarity for the non-racial democratic trade union movement and the national liberation movement as a whole.

The release of Walter Sisulu, Oscar Mpetha and other stalwarts of the anti-apartheid struggle in October 1989 was a great victory. But South Africa remains an imprisoned society. There are over seven hundred political prisoners in apartheid jails including many trade unionists. Amongst the sixty-seven opponents of apartheid on death row, there are five trade unionists.

When trade unionists have been released from imprisonment or detention many have faced severe restrictions and curfews which makes it impossible for them to carry out their union duties and liable to attack by state backed vigilantes and death squads.

The British government claims to seek a negotiated settlement to the political crisis in South Africa. But it steadfastly refuses to intervene in most cases where trade unionists are being repressed. The Organisation of African Unity has stated that the apartheid regime has to take steps to create the climate for negotiations in South Africa. Amongst these steps are:

- The release of all political prisoners and detainees unconditionally and to refrain from imposing restrictions on them;
- Lift all bans and restrictions on all proscribed organisations and persons;
- End the state of emergency and repeal all legislation, such as, and including the Internal Security Act, designed to circumscribe political activity;
- Cease all political trials and executions.
